 - James Island dispute
 - Guest: Mavis Underwood, Tsawout Councilor
 - Moving along, with support of CS and North Pender.. the settlers are standing up for protected rights – province not hearing their concerns – re continuity and support of rights via UNDRIP
 - They are struggling ways and means to do better financially and reclaim and protect
 - James Island very rich in medicinal plants
 - Govt approval for development they were kind of turned down –
 - Govt needs to hear the aural history re Douglas treaty it wasn't a buy out –
 - When the explosives plant was no longer needed it was to be returned to them but it got turned over to a hunting resort... so now fallow deer are invasive etc...
 - Need to get peoples to understand and stand with them to talk about remains etc...
 - So much history not understood or misunderstood by settlers..
 - James Island should have been protected by the DTA they should get it back
 - "consultation" now hasn't allowed them to really discuss w/govt
 - Helps here that Islands Trust folks now asking and talking about this issue..

 - Spoke w/Min Eby on this factor need to consider is, is it in the public interest they have to consider indigenous rights
 - 0
 - Social, economic, environmental cost is very high around this
 - What are options going forward? -
 - Can as a group send a message to ministry?...
 - Jane: can we pass resolutions at different Trust Committees or go through this Forum?
 - Mavis yes good to put in writing as support in the context of UNDRIP
 - <u>https://www.faithinthedeclaration.ca/</u> Faith in the Declaration is a coalition of Canadian faith houses and faith organizations working together to support the implementation of the UN Declaration on the Rights of Indigenous Peoples.
 - Missed what Mavis continued to discuss...
 - So many jurisdictions hard to deal with costly
 - Island represented so much food security, history,
 - Now they have a economic plan with Cascadia Seawood... seaweed planting...
 - Also looking at it for a field site for Indigenous Law.
 - Deb: agreed if we could all speak out to support this issue...
 - including framing it around reconciliation
 - Adam reconciliation is making decisions differently than we used to ...
 - Indigenous tired of tip of the hat and goes on and does something differently.
 - He and Mavis met wMoTI (?) yesterday James Island came up

- He's getting a meeting with the approval officer Bret X?
- He will draft a letter and send to all before sending out
- Mavis so much of the lands across Canada are unceded territories ... and so much bypasses FNs – roads, sewers, water...
- Laura James Island is in the Pender Trust as "Affiliated Islands" area so will bring up at next meeting on Tuesday
- Elizabeth: what can she do Federally?
- Mavis: re Douglas Treaty was important to leaders of FN back then in terms of their survival but now... this article gives good background: <u>https://www.gulfislandsdriftwood.com/news/north-pender-trustees-back-tsawout-in-</u> <u>subdivision-delay/</u>
- Adam: bkgrnd seller can't get a buyer so wanting to subdivide not really anything Federally right now – but thinking that maybe this is just a *farce in that the* developer wants Prov and Fed govt to step in and buy back for FNs...
- Chat from Gary: Is litigation aimed in part at seeking an injunction on the subdivision?
- **Chat from Adam**: I don't believe there is any litigation currently underway. Gailus is providing legal advice on the historic aspects of the Douglas Treaty
- Chat from Gary Certainly no expert, but wondering if an injunction could be a first legal step.
- **Chat from Deb**: I feel like it is all about the social media campaign right now, not even litigation.
 - How we make this a central issue of the thriving society of First Nations in our modern world with roots in their homelands in meaningful ways to be environmental leaders in our shared future!
- Laura: reminderThe province did lose to MCauw re cleanup.
- Talk about the letter
- Chat from Gary: Wondering if Jack Woodward would be willing to provide some advice.
- One of the lessons of Grace Islet was that the "approval process" allowed further development of the island, which drove up the cost to the Province of eventual acquisition.
- **Deb:** we could bring in others like Ecojustice group etc...
