  - Adam: yes there is, we go from time to time, but this would be specific to YVR flight paths
- **Deb**: was going to think on an initial plan for a potential SGI Forum website

  - He's been told the program is as it is. Gary how is the CRD going to be addressing this for the islands?
  - **Gary:** CRD set up an an application process for specific projects we'll see how funds are allocated for regional areas
    - Adam: he thinks that direction given by the province is not equitable
      - Gary: yes, he thinks rural areas are getting less than municipal
      - Adam: I have concerns of direction Min of Mun Affairs that is not taking its role seriously
        - Suggests advocacy from IT in support of regional districts representation – Action Item for ITs
          - o Tim: IT exec needs to be brought up to speed on this
            - Clare: she will Action Item
            - Adam: will share email he sent in support of Paul Brent's letter – see Addendum at bottom of notes
      - Dag: agrees and supports anything we can do about it
- Mairead: re: Governance of Islands different levels of funding make a table to summarize and ask for input from Forum members
  - Not at mtg today, not yet rec'd Action Item for Mairead

- Adam: re: Derelict Vessels will provide update re: "Coastal Marine Strategy" as he questioned Min. Cullen on it during budget estimates
  - Only got about 30mins with him spoke about biodiversity the Min. has done public consultations.
  - I've met w/EMay on this and there is a need for strong advocacy. I've witnessed whale watchers chasing whales was on the water with the WMGs would be good to have them working with the province
  - also talked w/Murray Rankin as he has property on SGIs and sees this happening.
  - 'Coastal Marine Strategy' should be turned into a 'Coastal Marine Act'
  - Laura: of note over 200 buoys in areas that are marine sensitive so not being regulated. All of this has to be dealt interjurisdictionally
    - Ben: of note Canadian xxx says every citizen is allowed a mooring buoy for ind. Use and complies w/reg. so just a caution re: 'us' trying to regulate. Suggests sitting down w/TC on this issue.
      - Adam: agrees. And need clarification with provincial jurisdiction. And need regulations administered.
  - **Clare**: she will circulate some recent legal commentary
    - O DONE She put in chat: BC's Mooring Buoy FAQ's
  - Adam: A Coastal Marine Act could have this all laid out in it
  - **Gary in chat**: "It would be useful if Adam and Elizabeth could organize a meeting with relevant provincial, federal, Trust and CRD staff regarding how to better manage harbours within the gulf islands. CRD has established a sub-regional service involving the 3 peninsula municipalities regarding harbours, but have not ventured into establishing an actual management regime."

  - o "Hello Mairead, In response to your enquiry about whether the Islands Trust was contacted by Nav Canada (a privately run, not-for-profit corporation that owns and operates Canada's civil air navigation system) regarding the flight path changes I don't believe we were. Below is the e-mail that Chair Luckham sent to NavCanada in February. I do not think that he received a reply. I've cc'd him so he can confirm this and so that you can coordinate any further work towards advocacy. At this time there is no political direction for advocacy and no Islands Trust position. "Hello Minister Kang,

Thank you for taking the time to meet with me last week to hear about the significant governance challenges facing communities in my riding.

Unfortunately, I only met with CRD Director Paul Brent on Sunday to discuss the Growing Community Fund and how the policy has further added frustration in the Southern Gulf Islands.

I have forwarded his email to me along with a brief that was prepared by Director Brent and his colleagues at the Capital Regional District. You mentioned to me that your goal was to support Minister Kahlon in getting housing approved and built in communities.

As Director Brent has outlined here, event with approvals in place, none of the programs, services, or policy, is designed to prioritize housing in these rural communities.

I hope you will be able to help remove some of the obstacles that have been put in place by the various governing bodies to get these projects with approvals moving, to amend the policy guiding the GCF to provide the flexibility needed to provide funds that are essential to supporting these projects, and finally to assist with streamlining the governance processes to better reflect the goals of the community in identifying and delivering the housing needs in our rural island communities.

I look forward to working with you on this critical project."

I am following up on this email I sent on April 24th forwarding information from CRD Electorial Area Director Paul Brent (Southern Gulf Islands) and the impact of policy for the Growing Communities Fund.

I am deeply concerned that the Province has created yet another program and negatively impacts the Southern Gulf Island communities.

As I have raised with the provincial government many times, these communities continually get overlooked and excluded from programs and services for a variety of reasons. I most recently explained these factors to Minister Kang and noted them with Minister Kahlon.

I am hoping there is some resolution to the Growing Community Fund please advise."

Adam, thank you for facilitating the visit to the island with Minster Fleming. The idea of initiating regular interagency staff-to-staff meetings is well supported by the existing letters of agreement between the Islands Trust and the Ministry of Transportation and Infrastructure. In the 1996 Amending Agreement \*(attached), it says:

"The parties agree to maintain an Interagency Task Force for the purposes of: dealing with arising issues; establishing an annual work program to ensure staff liaison, develop further road standards agreement, and review agency initiatives, legislation, bylaws, and programs of mutual interest; and meet at least twice annually for the above purposes."

While this agreement pertains to the entire Trust Area, it only makes sense to have a regional interagency task force for the islands in the CRD.

If using the existing agreements can facilitate and frame the interagency staff to staff meetings, I am more than happy to pursue this initiative in cooperation the CRD. Since the agreement anticipates the development of this interagency task force, I do not believe we require any political direction from the trustees to get it up and running, but staff may wish otherwise.

I also want to bring attention to the shoulder width standards. See page 31 in the attached agreement. An 1.8 m width for shoulders was agreed to for Fulford to Long Harbour.
