 Stewardship Program
 - And just found out that funding set up under oceans protection act is over just as the tankers start to flow the money has stopped – not even sure the office will still be in place
 - also on-going conversations around dock management issues... starting to be organized and a more coherent response to Prov govt
 - "Ben and Dag concurred on the timing of the program cuts and agreed on the need for further action, with Dag suggesting to raise the issue to the appropriate levels."
 - Dag: very concerning re program cuts when it is most needed what can we do?
 - Adam: agreed some dramatic action needs to be taken let's[discuss] fully in July meeting Action Item
